





## RENEWING OUR FUTURE

#### THE CAMPAIGN FOR ARCHBISHOP CURLEY HIGH SCHOOL

St. Francis of Assisi, praying before the San Damiano crucifix, heard the voice of Jesus tell him to "rebuild my church."

At first St. Francis understood his call to repair the crumbling San Damiano church and other nearly abandoned churches in the area. In time, he came to realize "rebuild" was a call to a spiritual mission, to renew people's lives and spirits. For almost 800 years the Friars and their co-workers have "rebuilt" as needed, with the goal of "renewal" always before them.

# \$4 MILLION FOR CAPITAL IMPROVEMENTS

Built in 1960-61, in the solid and now classic mid-20<sup>th</sup> century design, the Curley building is nearing 60 years of age. Today's student experiences white boards and flexible seating geared for collaborative work, while using technology at every turn. Renewing Our Future will provide 21<sup>st</sup> century classrooms that assure our students of today and tomorrow are ready for college.

Renewing Our Future will install air conditioning in the classroom building and the gymnasium. "Putting the A.C. into A.C." not only keeps Curley on par with its competitors, but opens the possibility for year-round usage for supplemental courses and camps. With an effort to air condition all public schools in Maryland, and with the majority of private schools already air conditioned or in the process of doing so, Curley cannot fall behind. The gymnasium is not only a key location for physical education and sports activities, but also for social and fund-raising events, and air conditioning will be most welcome for numerous events.

Renewing Our Future has the goal to re-furbish the academic building, including new floors and doors, ceilings and lighting, desks and furnishings, as needed. Concepts include re-configuring the Main Office so the receptionist can welcome and direct visitors as they

come in the front door, assuring increased security in the process. The goal for the front entrance and first floor corridor is to present a more welcoming and contemporary look, with the goal of bringing more natural light into the space. The STEM rooms will be re-organized for the use of more technology, including projects and robotics. The school kitchen and cafeteria serving line remain in their original form, and will be re-designed for a more contemporary collegiate feel, with stations to expedite serving.

# \$1.5 MILLION FOR FINANCIAL ASSISTANCE FOR DESERVING STUDENTS

Financial Assistance has become an essential for many families as Catholic high school tuitions have steadily increased. Curley remains as affordable as any, with the 2018-19 tuition rate of \$14,450. Almost 80% of the student body receives some form of merit or financial aid, with a total budget of \$1,800,000. While the number of endowed scholarships and financial aid sources continues to increase, there is a Campaign goal of \$1.5 million for financial aid/tuition assistance, and will be of crucial assistance in the next five years, an amount that will be directly awarded as it is collected each year.

### **Where Brotherhood Begins**

A strong academic program, designed for 21st century learning, a competitive athletic program and a diverse arts program are hallmarks of a Curley experience. What makes Curley truly unique, however, is the Franciscan dimension, which values the individual and emphasizes Franciscan ideals for learning and life. It is a school "where Brotherhood begins."



# \$1.5 MILLION FOR THE ANNUAL FUND

The Annual Fund goal asks that donors to the Campaign also commit to their Annual Fund gift during this time, assuring that these needed dollars for the annual budget will be present as the Campaign unfolds.
